SUBJECT: Consideration of a Memorandum of Understanding between the Marin Agricultural Institute (Marin Farmers Market) and the Town of Fairfax for the 2012 Fairfax Farmers Market

RECOMMENDATIONS

1. Approve the Marin Agricultural Institute (formerly known as the Marin Farmers Market) attached Proposal
2. Hold the Farmers Market in Bolinas Park
3. Approve dates of May 2nd-September 26th each Wednesday from 4-8 PM.
4. Accept \$1000 from the Chamber of Commerce to mitigate the damage to the turf
5. Have the Farmers Market provide a public restroom
6. Have the Farmers Market provide a portable stand-alone sign

DISCUSSION

Last year, the Farmers Market was held in Bolinas Park for the sixth year. The response from the community to this location was very positive, as it is a great venue for gathering and picnicking. Damage did occur to the grass and Public Works staff worked very diligently to repair the damage and refurbish the turf to its former state. A contribution of \$1,000 was made by the Fairfax Chamber of Commerce toward this effort.

On March 29, 2012 the Marin Agricultural Institute (Marin Farmers Market) provided a formal request to the Town for the 2012 Farmers Market (see attached) to hold the Market in the same location. They are requesting a start date of May 2, 2012.



Subject: Fairfax Farmers Market Proposal



Market Location & Times

- The Fairfax Farmers Market will take place at Bolinas Park on Wednesday evenings 4pm-8pm.
- The market will open on **May 2nd** and close on **September 26th**.
- Approximately 30 local farmers, food purveyors and artisans will participate in the market. They will be positioned along Winnie Lane, Bolinas Road, Elsie Lane, and in the Redwood grove.

Road Closures and Parking

- Winnie Lane will be closed to the public between the hours of 3pm and 9pm. Vendor parking will only be allowed on the side of Winnie Lane closest to the park turf area, allowing one way access for Fairfax Police and Public Works vehicles.
- Town employees will be asked to move their vehicles from Winnie Lane at 2:30 pm
- Elsie Lane will be partially reserved for vendor parking including the three spaces that border the park and the first four spaces below the main parking lot, between the hours of 2:30 pm and 9 pm.
- No parking signs will be posted along Elsie Lane and Winnie Lane by AIM staff on Tuesdays by 2:30 pm.

Trash and Portable Restroom

- AIM will provide and maintain a portable restroom for the duration of the season.
- AIM will provide additional trash receptacles during the market. The park's permanent trash receptacles will be emptied prior to the market by Public Works. AIM will be authorized to use the public works dumpster at the end of each evening to dispose of food trash and paper trash.

Generators & Park Protection

- Any and all generators will be positioned as far away from Town Offices as possible.
- AIM staff will be watchful of any activity that would do harm to the park or park turf.

Plastic Reduction Ordinance

- The Fairfax Farmers Market will continue to abide by the Town of Fairfax's Plastic Reduction Ordinance. We are proud to be AIM's first plastic bag free market.

Subject: Farmers Market Guidelines for Park Use

In response to the Farmer's Market intentions for the 2008 season, the Public Works Department offers the follow guidelines for use:

1. Vendors and entertainers must be located on 'non-turf' areas. Booths can be set-up in the redwood groove with at least two feet of non-turf frontage.
2. Vendors cannot use hot kettles or other devices that leave scorch and burn marks in the terrain and present fire hazards. Last year, the popcorn vendor killed a section of grass by burning it with the hot kettles.
3. All food trash, paper trash, and storm drain pollution by the Market vendors need to be removed from the park prior to their departure each week.
4. If loud generators are used, for example with the bounce house, the generator needs to be the quiet model or else positioned away from the Town Offices.
5. Market staff are asked to be watchful of activities not listed that may damage our park in any way.
6. Repairs for turf or other damage to the park will be charged to the Farmer's Market. Last year, the bubble artist killed a section of grass by having the soap make contact with the turf.
