**SUBJECT:** Interview of candidates for appointment to complete the term of resigned Councilmember O'Neil or to serve until the November 2013 election

### Recommendation

Interview candidates to fill the Town Council vacancy.

### Discussion

At the March 14<sup>th</sup> meeting, the Council provided input on the interview and appointment process for selecting a replacement for Councilmember O'Neil's vacant seat. The Council also selected March 21<sup>st</sup> as the date for the interviews. All the applicants were informed of the meeting place and time and given a copy of the attached selection process. Also attached for your reference are the Council candidate applications. One applicant, Raymond Burgarella, has withdrawn from the selection process.

Staff is recommending that the Council conduct the selection process, but defer the appointment to the April 3<sup>rd</sup> meeting. This would provide the Council with the flexibility to consider an ordinance, also on this evening's agenda, which allows the Council to appoint someone to fill the vacancy on an interim basis until a special election can be held. Due to the timing, this special election would be held on the next regularly established election date which is November 2013. Should the Council decide not to introduce the first reading of such an ordinance, the selected candidate would serve the remainder of the term until November 2015. However, in either case, the appointment would be made at the April 3<sup>rd</sup> meeting, which meets the statutory requirements of the Council calling an election and making an appointment within 60 days of a resignation.

Council-Adopted Process for Interviews and Selection:

1. When the applicants arrive, staff will randomly draw numbers to set the order of the presentations.
2. As a courtesy to the other applicants, Council will request that all applicants wait in the lobby or other waiting area while any one applicant is making his/her presentation.
3. Each applicant will have 10 minutes to make a presentation and to answer any questions from the Council. Applicants have been given the following three questions to cover in whatever level of detail they desire in their presentations:
  - Cite three top goals for the Council and your reasons for considering them high priority.
  - What program/budget areas would you advocate be increased, and how would you fund these increases?
  - Please give us more detail on what your vision is for the Town of Fairfax.

The questions are meant to provide some basis by which the Council can compare the presentations. Staff will set the timer for 10 minutes and presenters will be informed when 1 minute remains. No additional time will be permitted.

4. After the presentations are completed, all applicants will be invited back into the meeting room to hear the first step in the Council deliberations.
5. The first step will be for the Council to create a list of finalists by having each of the Council select his/her top two applicants. Staff will create a list of the finalists based on the Council vote.
6. One by one (in alphabetical order by last name), the finalists will then be interviewed by the Council.
7. Once again, the Council will ask that all of the finalists leave the meeting room and return to the lobby while any one finalist is being interviewed. The Council will ask questions of each of the finalists. Finalists will have 5 minutes to answer questions, if more than three (3) finalists are selected. If 3 or fewer finalists are selected, then each finalist will have 10 minutes to answer questions.
8. When all interviews have been completed, all finalists will be invited back into the meeting room to hear the final step in the deliberations.

9. Each Councilmember will then rank his/her choices, with Rank 1 earning 3 points Rank 2 earning 2 points, and Rank 3 earning 1 point. Staff will tally the points and report the results to the Council.
10. Town Council will, by motion, make their decision that night or defer it to another meeting.
11. If Council makes a decision, the newly appointed Councilmember will take his/her oath of office at the next Council meeting.

Dear Mayor Reed and Members of the Town Council:

In light of Councilmember O'Neil's resignation, I am applying to fill the vacancy on the Council. I look forward to the opportunity to interview and feel that I am a very strong candidate based on my years of public and community service, my leadership skills and broad range of experience. I have enclosed my application and my resume.

I have devoted most of my adult life to public service and have a proven track record of accomplishments which have benefited the communities of California and the Bay Area. I have lived in Fairfax for 17 years, and for the last several years have volunteered to serve our Town on both the Open Space Committee and the Planning Commission.

I currently work for the Bay Area Air Quality Management District, protecting public health through enforcement of air quality laws and regulations. I led my staff to create and implement the first air district enforcement program to reduce carcinogenic diesel and other air emissions from "mobile sources" (trucks, ships, boats, trains, construction equipment), focusing these efforts in environmental justice areas. I have led our Air District in working with the state's Air Resources Board and other districts to implement climate change initiatives statewide. I previously worked for the California Department of Toxic Substances Control (DTSC) for 23 years, establishing regulatory policy, developing legislation, remediating hazardous waste sites, ensuring permitted facilities were protective of public health and the environment, and facilitating meaningful public involvement. Among other things, at DTSC I created a new state program, the first of its kind in the nation, to ensure that K-12 public schools are built on environmentally safe properties, protecting the health of California's children. I also created the State's innovative programs to cleanup, reuse and recycle formerly contaminated properties and promote infill development. Through national organizations, I also led teams and coordinated matters of national environmental policy debate.

I believe my skills would serve our town well. I am both a strong collaborator and leader. I am decisive. I am a good listener, and am interested in all perspectives. We are fortunate to have an engaged, diverse community representing many multi-faceted ideas and beliefs. A key focus of my efforts through the years has been cross-sector coalition building and conflict-resolution. And while addressing local issues is critical for our town, we shouldn't limit our reach; we should consider national and worldwide issues in our deliberations to continue Fairfax's leadership on larger policy matters. We can put pressure on federal and state leaders (and others) to change direction and decisions as Fairfax is an important member of the global community.

I would love the opportunity to serve our town as a member of the Council. This is a critical time for Fairfax, with many changes in staff and leadership. **Career Executive Assignment II - Division Chief**

**Permitting and Corrective Action Division**

**May 1, 2003 – April 2007**

Statewide position responsible for the technical, administrative and fiscal management of approximately 130 division staff housed in DTSC's four regional office locations. U.S. EPA authorized DTSC to implement the Resource, Conservation and Recovery Act (RCRA) program in California, the primary large component of the division's mission. Responsible for leading, directing, planning, prioritizing and organizing the activities of a multidisciplinary staff working within this complex regulatory program. Oversaw managers and staff responsible for permitting facilities to treat, store, dispose and transfer hazardous waste in accordance with federal, state and local laws. Permitting responsibilities included assuring these facilities met requirements for environmental safety, financial assurance, and environmental monitoring. As Division Chief, also responsible for corrective action and closure, including the long-term maintenance for more than 300 closed hazardous waste facilities (and generating revenue of more than \$3 million in cost reimbursement per year to support staff work). Significantly increased productivity (~ 300% increase) and timeliness (reduced from average of about 4.5 years to 2+ years) while ensuring environmentally protective permitting of hazardous waste facilities.

In October 2004, Ms. Coler was awarded a U.S. EPA Leadership Award for Corrective Action Environmental Indicators (EIs). As a result of her leadership, her Division received awards from U.S. EPA for achieving its targets for EIs, permits and corrective action milestones in 2004, 2005 and 2006. Ms. Coler represented Region 9 States on U.S. EPA's RCRA 2020 Corrective Action Initiative national workgroup. As a key member of the group, Ms. Coler was a leader in developing national policy to implement this component of the RCRA 2020 vision. Ms. Coler also represented California and Region 9 States on the Association of State and Territorial Management Officials' (ASTSWMO) Corrective Action and Permitting Task Force.

At request of the then DTSC Director, Ms. Coler acted as the lead negotiator with a responsible party (PRPs) group (of over 25 members) to takeover and assume financial responsibility for operations at a hazardous waste landfill in Southern California. Under Ms. Coler's direction, DTSC was able to affect a voluntary agreement with the parties for monthly payments for operations of the landfill systems resulting in multimillion dollar savings/recovery for DTSC. With her further management, a Consent Decree was signed in early 2006, and the PRPs assumed lead on the landfill operations.

#### **Career Executive Assignment II - Division Chief**

Statewide position responsible for the technical, administrative and fiscal management of approximately 120-150 division staff housed throughout California. Effectively communicated program objectives in non-technical terms to diverse stakeholder interest groups.
- Led and directed staff in formalizing the Voluntary Cleanup Program to foster environmentally sound redevelopment and/or revitalization of Brownfields and other contaminated properties.
- Led Total Quality Management (TQM) Team to develop DTSC's Prospective Purchaser policies, aimed at fostering Brownfields reuse while protecting human health and the environment.
- Completed DTSC's "site" database validation project, deleting approximately 24,000 invalid listings which resulted in removing the economic devaluation by the environmental stigma for these properties.
- Key DTSC representative regarding State Superfund Statute Reauthorization.
- Developed legislation and infrastructure for DTSC's environmental schools program; the first of its kind in the nation. Involved diverse stakeholder groups to resolve contentious and complex technical and policy issues while developing the program.
- Represented California and the National Governor's Association (NGA) on key legislative debates regarding Federal Superfund Reform; testified on behalf of Governor Wilson and NGA before the U.S. Senate Environment & Public Works Committee.
- Chair of the Association of State and Territorial Solid Waste Management Officials (ASTSWMO) Brownfields Task Force for eleven years. Leader on national policy regarding voluntary cleanup, Brownfields redevelopment and Superfund cleanup. Also represented California on ASTSWMO's CERCLA Committee which developed national policy in conjunction with U.S. EPA. Chaired and developed five ASTSWMO Voluntary Cleanup/Brownfields Symposia for all States and U.S. EPA.
- Listed by CA Department of Justice as Expert Witness on the federal National Contingency Plan.

Montrose Site settlements – In partnership with U.S. EPA, with the California Department of Justice, Ms. Coler acted as the lead negotiator for the State of California with the Montrose PRPs ("the DDT dischargers"). Three significant settlements were achieved under her leadership for the Montrose site in Southern California. The first 2002 Consent Decree settled the Natural Resources Damages lawsuit and CERCLA claims against the Montrose entities - the companies paid \$73 million to cleanup DDT contamination and restore the ocean environment off the coast of Palos Verdes. The latter two Consent Decrees settled the liability of the PRPs for the surface water pathway from the Montrose site and the residential neighborhood, resulting in payments of nearly \$2.5 million and a savings of more than \$10 million for the residential cleanup.

In addition to other DTSC management positions, Ms. Coler has served as a project manager responsible for cleanup of regional groundwater sites in Southern California. She was an environmental consultant at the Savannah River Nuclear Production facility in South Carolina. She was a research associate conducting environmental monitoring for the State of Kansas Biological Survey.





Why do you want to be considered for the position of Town Council member?

I have learned my style of leadership, and to stand for visionary thinking from a realistic perspective. I am deeply dedicated to hearing all people's points of view and see myself primarily as a bridge.

I am eager to apply my skills to working on The Town Council.

What are the 3 main issues facing the town of Fairfax?

1. We are sorely lacking a useful community space and sufficient community resources for Middle and High School aged youth. (our future). Sustainability is a word that simply means 'continue to exist' and is often referred to when people speak of Fairfax

and our focus on Environmental stewardship, the organics movement, and the plethora of healing mediums we house here. We cannot identify ourselves as sustainable if we don't start prioritizing youth centered programs and spaces and a focus on equitable, accessible activities and venues within the community.

2. We need to focus energy on a careful design for transit oriented development which matches our town's unique character and the great variety of people's needs. We presently have no public transport access from the hills and limited safe routes from the neighborhoods for youth walking or biking and for isolated Seniors with no access to community, without a car.
3. Emergency preparedness: We do not have official and clearly defined plans custom to each neighborhood and their particular safety challenges. We need to educate each citizen on how to access emergency information and protocols for flood, fire or other natural disaster.. ie: We have sirens, but nobody seems to know what they signify.

What is your vision for the town of Fairfax?

I envision a town where people want to participate and join commissions and choose to volunteer because they feel their ideas are valued and will be respectfully considered; a place where people step up for what they want and believe versus fighting against what they don't want. Kudos to present council who have created a comfortable and welcoming forum.

Fairfax has modeled the power of local democratic decision making as a driver for change which the County of Marin seems to be scrambling to keep up with. Fairfax is the final destination before THE HILL, the gateway to West Marin, and everyone's favorite place to stop for a visit. I envision an expanded local economy, which can afford to provide for the visitors as well as supply the items to meet citizen's basic consumer needs, which now we go elsewhere to buy.

I envision as many youth music, art, multi media and sports venues as there are bars. A safe lane for bicycles and car share programs to enable people to transport themselves without owning 2 cars which now contributes to car lined streets whether parked or in motion. I envision community gardens, and programs like Resilient Neighborhoods becoming part of Fairfax's Climate Action Plan.


