RESOLUTION NO. 13 - 21

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX CALLING FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION ON NOVEMBER 5, 2013, FOR THE ELECTION OF CERTAIN OFFICERS, REQUESTING THE MARIN COUNTY BOARD OF SUPERVISORS TO CONSOLIDATE WITH ANY OTHER ELECTION CONDUCTED ON THAT DATE, AND REQUESTING ELECTION SERVICES OF THE COUNTY CLERK

WHEREAS, three four-year terms of office on the Fairfax Town Council will expire on November 5, 2013; and

WHEREAS, pursuant to Sections 10002 and 10403 of the Elections Code, the above stated Governing Body may request the Board of Supervisors to permit the County Clerk to render specified service to said Body relating to the conduct of the election on a reimbursable basis.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Fairfax as follows:

1. That an election is hereby called to be held on November 5, 2013, at which election three council seats will be determined; and
2. That the Board of Supervisors of the County of Marin is hereby requested to consolidate said election with any other applicable election conducted on the same day (including the special election called by the Town of Fairfax on April 3, 2013 pursuant to its Resolution); and
3. That the Board of Supervisors of the County of Marin is hereby requested to authorize the County Clerk to render all necessary election services to canvass the results of said election; and
4. That the Town Clerk is hereby ordered and directed to file a copy of this resolution with the Board of Supervisors of the County of Marin.

The foregoing resolution was duly and regularly adopted by the Town Council of the Town of Fairfax, County of Marin, State of California, at a regular meeting thereof, held on the 1st day of May 2013, by the following vote to wit:
