RESOLUTION 13-

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX, RECITING THE FACT OF THE GENERAL ELECTION HELD ON NOVEMBER 5, 2013, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, A General Election was held and conducted in the Town of Fairfax, California, on Tuesday, November 5, 2013, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolutions 13-13 and 13-21 of the Town Council of the Town of Fairfax, adopted April 3, 2013, and May 1, 2013, respectively, the County Election Department canvassed the returns of the election and has certified those results to this Town Council, the results are received, attached and a part hereof as "Exhibit A."

NOW, THEREFORE, the Town Council of the Town of Fairfax, California, does resolve, declare, determine and order as follows:

SECTION 1. That the whole number of ballots cast in the precincts was 4753 for Councilmember, Full Term, and 1411 for Councilmember, Short Term, including Absentee and Provisional Ballots; and

SECTION 2. That the office, the names of the candidates voted upon at the election and the total number of votes each received were as follows:

Town Council Member Full Term:

BARBARA COLER	1449	30.49%
DAVID WEINSOFF	1446	30.42%
JOHN REED	1425	29.98%
CHRISTOPHER H. LANG	417	8.77%
Write-In Votes	16	0.34%

Town Council Member Short Term:

RENEE GODDARD	1390	98.51%
Write-In Votes	21	1.49%

SECTION 3. That the number of votes given at each precinct and the number of votes given in the Town for each candidate are as listed in Exhibit "A" attached.

SECTION 4. That as a result of the election Barbara Coler, David Weinsoff, and John Reed received the highest number of votes and were elected as Councilmembers, Full Term; and Renee Goddard received the highest number of votes and was elected as Town Councilmember, Short Term.

SECTION 5. The Town Clerk shall enter on the records of the Town Council of the Town, a statement of the result of the election, showing: (1) the whole number of ballots cast in the Town; (2) the offices voted upon; (3) the number of votes given at each precinct for each candidate; and (4) the total number of votes given for each candidate.

SECTION 6. That the Town Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Town Clerk and authenticated; that the Town Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the Town Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. That the Town Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

The foregoing Resolution was duly introduced and adopted at a regular meeting of the Town Council of the Town of Fairfax held in said Town on the 4th day of December 2013, by the following vote, to wit:


