**SUBJECT:** Interview and appointment of youth applicant to the Open Space Committee

#### **RECOMMENDATION**

Interview and appoint Lily Williams to the Fairfax Open Space Committee (FOSC).

#### **DISCUSSION**

Lily Williams submitted her application for the Fairfax Open Space Committee and attended their April 26th meeting. FOSC is unanimous and enthusiastic in their support of her appointment.

FOSC requests that the Council appoint Ms. Williams to one of the two non-youth vacancies on the Committee, instead of the youth vacancy. There are essentially three differences between a regular member and a youth member (not including the age difference):

1. a regular member can vote; a youth member cannot vote;
2. a regular member counts towards a quorum; a youth member does not;
3. a regular term is 3 years; a youth term is one year.

The practice of the Council has been to appoint applicants under age 18 to a youth position on a board or committee. While there is nothing in the Town Code or Town Council resolutions that specifically prohibits the Council from filling a regular vacancy with a youth, the posted Notice of Vacancy states: "Applicants must be at least 18 years old and reside in the 94930 zip code."
